- $I_{O}: \qquad \mbox{We recommend that the worst case current be no greater than 80\% of the absolute maximum rating of I_O and T_j be below 100°C. When using this device, take the margin into consideration by using an allowable Tamax-I_O curve.}$
- IFSM: This rating specifies the non-repetitive peak current. This is only applied for an abnormal operation, which seldom occurs during the lifespan of the device.
- $T_{j} : \qquad \text{Derate this rating when using a device in order to ensure high reliability. We recommend that the device be used at a T_{j} of below 100^{\circ}\text{C}.$


