


Figure 1. Forward Current vs. Ambient Temperature




Figure 2. Pulse Forward Current vs. Pulse Duration




Figure 3. Rel. Luminous Intensity vs. Angular Displacement




Figure 4. Relative Intensity vs. Wavelength




Figure 5. Forward Current vs. Forward Voltage




Figure 6. Specific Luminous Intensity vs. Forward Current






Figure 7. Rel. Luminous Intensity vs. Ambient Temperature



Mounting Pad Layout






Figure 8. Tape Dimensions in mm for PLCC-2

#### REEL PACKAGE DIMENSION IN MM FOR SMD LEDS, TAPE OPTION GS08 (= 1500 PCS.)




Figure 9. Reel Dimensions - GS08




Figure 10. Reel Dimensions - GS18

IR Reflow Soldering Profile for Lead (Pb)-free Soldering Preconditioning acc. to JEDEC Level 2a




Figure 11. Vishay Lead (Pb)-free Reflow Soldering Profile (acc. to J-STD-020C)





Figure 12. Double Wave Soldering of Opto Devices (all Packages)





#### DRY PACKING

The reel is packed in an anti-humidity bag to protect the devices from absorbing moisture during transportation and storage.



#### **FINAL PACKING**

The sealed reel is packed into a cardboard box. A secondary cardboard box is used for shipping purposes.

#### **RECOMMENDED METHOD OF STORAGE**

Dry box storage is recommended as soon as the aluminium bag has been opened to prevent moisture absorption. The following conditions should be observed, if dry boxes are not available:

- Storage temperature 10 °C to 30 °C
- Storage humidity  $\leq$  60 % RH max.

After more than 672 h under these conditions moisture content will be too high for reflow soldering.


In case of moisture absorption, the devices will recover to the former condition by drying under the following condition:

192 h at 40 °C + 5 °C/- 0 °C and < 5 % RH (dry air/ nitrogen) or

96 h at 60  $^{\circ}\text{C}$  + 5  $^{\circ}\text{C}$  and < 5 % RH for all device containers or

24 h at 100  $^{\circ}$ C + 5  $^{\circ}$ C not suitable for reel or tubes.
