



Light Current vs. Collector-Emitter






Voltage Characteristics (Typical)

Relative Light Current vs. Ambient Temperature Characteristics (Typical)




#### **Response Time vs. Load Resistance Characteristics (Typical)**







# Sensing Position Characteristics (Typical)




# Light Current vs. Forward Current Characteristics (Typical)
