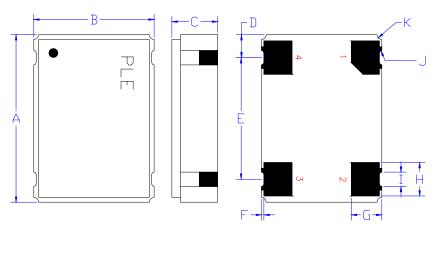

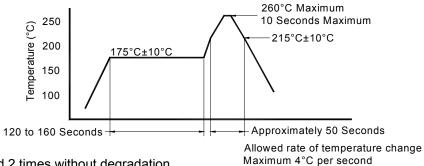
For Optimum Jitter Performance, Pletronics recommends:

The part may be reflowed 2 times without degradation.

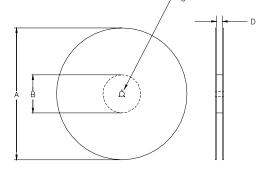

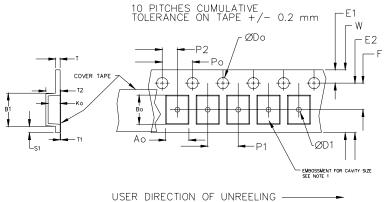
