GaAs Infrared Emitting Diode in Side View Package

Description

TSKS5400-FSZ is a standard GaAs infrared emitting diode in a flat sideview molded plastic package. A small recessed spherical lens provides an improved radiant intensity in a low profile case.

The diode is case compatible to the TEKS5400 photodetector, allowing the user to assemble his own optical sensor.

- Side view package with spherical lens
- Radiation direction perpendicular to mounting direction
- Angle of half sensitivity $\phi = \pm 30^{\circ}$

- Peak wavelength $\lambda_P = 950 \text{ nm}$
- Case compatible with TEKS5400




Figure 1. Power Dissipation vs. Ambient Temperature




Figure 2. Forward Current vs. Ambient Temperature




Figure 3. Forward Current vs. Forward Voltage




Figure 4. Forward Voltage vs. Ambient Temperature




Figure 5. Radiant Intensity vs. Forward Current




Figure 6. Radiant Power vs. Forward Current




Figure 7. Relative Radiant Intensity vs. Ambient Temperature




Figure 8. Relative Radiant Power vs. Wavelength





Figure 9. Relative Radiant Intensity vs. Angular Displacement

- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.

Vishay Semiconductor GmbH can certify that our semiconductors are not manufactured with ozone depleting substances and do not contain such substances.
