General Description


This P -Channel 2.5V specified MOSFET is produced using Fairchild Semiconductor's advanced PowerTrench process that has been especially tailored to minimize the on-state resistance and yet maintain low gate charge for superior switching performance.


These devices are well suited for battery power applications: load switching and power management, battery charging circuits, and DC/DC conversion.




Figure 1. On-Region Characteristics.




Figure 3. On-Resistance Variation with Temperature.




Figure 5.Transfer Characteristics.




Figure 2. On-Resistance Variation with Drain Current and Gate Voltage.




Figure 4. On Resistance Variation with Gate-to-Source Voltage.




Figure 6. Body Diode Forward Voltage




Figure 7. Gate Charge Characteristics.




Figure 8. Capacitance Characteristics.




Figure 9. Maximum Safe Operating Area.




Figure 10. Single Pulse Maximum Power Dissipation.




Figure 11. Transient Thermal Response Curve.



Component Rotation




Sketch B (Top View)

Component lateral movement






