


# Standard Bins for LC503TBG1-30Q-A ( $I_F = 20 \text{ mA}$ )







- 1. All ranks will be included per delivery; rank ratio will be based on the dice distribution.






FIG.2 REVERSE CURRENT VS. REVERSE VOLTAGE.








#### **Mechanical Dimensions**

All dimensions are in mm. Tolerance is  $\pm 0.25$  mm unless otherwise noted.

An epoxy meniscus may extend about 1.5 mm down the leads.

Burr around bottom of epoxy may be 0.5 mm max.


