






Figure 1. 8/20 μs Peak Pulse Current wave form acc. IEC 61000 - 4 - 5




Figure 2. Typical Capacitance C_{D} vs. Reverse Voltage V_{R}

Figure 3. Typical Forward Current $\rm I_F$ vs. Forward voltage $\rm V_F$





Figure 4. Typical Reverse Voltage V_R vs. Reverse Current I_R




Figure 6. Typical Clamping performance on - 8 kV - ESD events (Acc. IEC 61000-4-2)




Figure 7. Typical Clamping performance on + 8 kV - ESD events (Acc. IEC 61000-4-2)




Figure 8. Typical max. Clamping voltage at ESD contact discharge (Acc. IEC 61000-4-2)






Application Note:

a) With the VESD05A1-02V one signal or data line (L1) can be clamped to ground. Due to the different clamping levels in forward and reverse direction the VESD05A1-02V clamping behavior is <u>Bi</u>directional and <u>Asymmetric</u> (BiAs).
