




PERFORMANCE CURVES

40 P_D (W) 32 POWER DISSIPATION 24 16 8 0 L


POWER DISSIPATION DERATING CURVE




MAXIMUM SAFE OPERATING AREA



DRAIN-SOURCE VOLTAGE VDS (V)








